# History of the institute

## **Establishment of the institute**

ISDPR is one of the oldest institutes in Seoul National University. With a great help of professor Hae-young Lee in the department of Sociology, it was started in 1964 as Population Research Center, and officially established in August 1965 by the fund of Population Council in New York. Since then, the institute has conducted remarkable research activities including collection of population data and field studies. Later, as expanding the research domain gradually, ISDPR was renamed as the Institute for Population and Development in 1968. ISDPR has made widely recognized contributions to make policy agenda in population issues and family planning, rural social system and social transformation of Korea.

# Development of ISDPR in a new era

Drastic transformation of Korean society required recognizing the need for new research agenda and methodology. Corresponding to the emerging needs, the institute restructured the research agenda and organization. This shift was followed by renaming the institute to the current title, The Institute for Social Development and Policy Research in 1995, its 30th anniversary. Since then, the aim of ISDPR has focused on generating knowledge and articulating policy alternatives that address social development and change in Korean society. In addition, ISDPR undertakes international comparative research including Asia and Europe to enhance mutual understanding on academic and practical activities.





## **Population and Ageing Society Research Center**

The Institute for Population and Development, played a critical role in articulating policy agenda in population issues. Following this precious tradition of the institute, this center provides a space for population studies researchers to discuss and generate knowledge, exchange ideas, collaborate on research and teach the future scholars.

# SNCC (Social Network Computing Center)

Established in 2012, SNCC is the newest addition to ISDPR. As the name implies, SNCC focuses on social network analysis dealing with big data. With the exponential growth of data size, conventional methodology may no longer work for social sciences. As the first of its kind in the field of social sciences, SNCC strives to open the new era of computing. SNCC has been very successful in analyzing voluminous amount of structured and unstructured data from social network services (SNS) and other online sources. SNCC is jointly operated by ISDPR and Cyram Inc., the developer of NetMiner. It also provides social network analysis education program every month.

# Ongoing research projects

### **NRF Core Research Institute Program**

#### "Social Quality Research"

For the first (2008-10) and second (2011-13) period, we successfully built a vibrant academic community in social quality research. In addition, 1st and 2nd Wave of SQSQ (Standard Questionnaire for Social Quality) were completed. For the third (2014-16) period, we analyze different social policy regimes as well as present alternative social policy agenda to achieve sustainable and creative society.

## **NRF SSK Program**

"Models and Measurement of Social Integration"

Social integration has now become the first-priority policy goal in many countries in the middle of increasing competition all over the world. ISDPR compares Korea and relevant foreign countries in terms of social integration and social policy. In the first year of this program we compared Korea and Turkey. In 2012 ISDPR carried out standardized surveys in Germany, Italy, Greece, Turkey and Korea to understand the social aspect of economic crisis and derive implications for social integration.

### **Collaboration with SBS**

ISDPR and Seoul Broadcasting System (SBS) signed a ten-year MOU in 2011. Every year ISDPR undertakes research that is of central importance to Korean society with funding provided by SBS. ISDPR publishes the results and SBS broadcasts the contents in various programs such as its flagship annual special Future Korea Report, documentaries, and news.

# **Presidential Commission for National Cohesion**

ISDPR, collaborating with Presidential Commission for National Cohesion in Korea, aims to achieve social cohesion by the value of trust, reducing social conflicts, decreasing socioeconomic gaps and building cooperation between the conservatives and the radicals. ISDPR conducts a monthly monitoring project about social conflicts to find and develop research agenda. Active involvement of NGO and other civil actors is encouraged to exchange information and establish a network under this project.

# Public transportation from Incheon Airport

#### **Limousine Bus**

The 'Limousine bus' is a convenient and inexpensive way to get to SNU Gwanak Campus from Incheon International Airport. Take airport limousine bus number 6017 or 6003. The bus 6017 comes directly from Incheon to SNU rear gate (Hoam Faculty House) within 70 minutes. The bus 6003 comes to SNU main gate via Gimpo Airport, and it takes 110 minutes under normal traffic conditions. Service is available everyday from early morning to night time at Incheon International Airport with no charge for the baggage.

#### Taxi

The taxi fare for coming to SNU Gwanak campus from Incheon International Airport is around 60,000 won depending on the traffic situation. By Deluxe Taxi (Mobeom Taxi), which offers high-quality service, the approximate fare is 80,000 won.
